*I acknowledge and represent that I have the authority to represent my business, organization, or group (the "Group") and bind such Group to the date, time and financial commitments listed herein for the purpose of touring AT&T Stadium. I understand the date, time, and tour content (i.e., accessibility to certain areas inside AT&T Stadium) is subject to change based on, among other things, force majeure events, NFL rules and other AT&T Stadium events. No refunds or exchanges will be permitted based on scheduling or tour content changes. In the event the private group tour (the "Tour") is cancelled and not rescheduled, the sole and exclusive remedy available to the Group is a refund of the face value of the Tour ticket only and the Stadium will not be liable for, among other things, (i) any indirect, consequential or incidental damages; (ii) reimbursement of any travel-related expenses; or (iii) any delay causing the Group to arrive late or miss the Tour for any reason. Any ticket issued to the Group in relation to the Tour is a revocable license and may be revoked and admission refused at any time to any person whose conduct is deemed by Legends Hospitality, LLC, AT&T Stadium, L.P. or any affiliate thereof (together the "Stadium") to violate the terms and conditions contained herein or on the back of the Tour ticket, or for any other reason at the sole discretion of the Stadium. The Group assumes all risk and rise of injury related to the Tour (including playing or running on the field) and agrees to obey the directions and instructions of Stadium personnel. The Group also agrees that they are not acting for the Stadium in any manner whatsoever and that they are not an employee or agent of the Stadium. **THE GROUP AGREES TO NOT SUE, INDEMNIFY AND HOLD HARMLESS AT&T STADIUM, L.P., LEGENDS HOSPITALITY, LLC, BLUE STAR OPERATIONS SERVICES, LLC, DALLAS COWBOYS FOOTBALL CLUB, LTD., THE CITY OF ARLINGTON, ITS AFFILIATES, AGENTS AND EMPLOYEES (THE "RELEASED PARTIES") FROM AND AGAINST ALL LIABILITY, LOSS, DAMAGE OR EXPENSE RESULTING FROM OR ARISING OUT OF THE ISSUANCE AND ACCEPTANCE OF THIS ORDER FORM, ISSUANCE OF ANY TOUR TICKET OR THE GROUP'S PRESENCE IN AT&T STADIUM, EVEN TO THE EXTENT THAT SUCH LIABILITY, LOSS, DAMAGE OR EXPENSE ARISES OUT OF THE NEGLIGENCE, WILLFUL OR INTENTIONAL MISCONDUCT OF THE RELEASED PARTIES, OR ANY OTHER INDEMNIFIED PARTY. THE RELEASED PARTIES ARE NOT RESPONSIBLE FOR LOST, STOLEN OR DAMAGED PROPERTY. IN ADDITION, THE GROUP HEREBY WAIVES ANY AND ALL RIGHTS OF RECOVERY, CLAIMS, ACTIONS OR CAUSES OF ACTION AGAINST THE RELEASED PARTIES, FOR ANY LOSS OR DAMAGE WHICH IS INSURED AGAINST (OR WHICH IS REQUIRED HEREUNDER TO BE INSURED AGAINST), REGARDLESS OF CAUSE OR ORIGIN, INCLUDING NEGLIGENCE OF THE RELEASED PARTIES, AND THE GROUP COVENANTS THAT NO INSURER SHALL HOLD ANY RIGHT OF SUBROGATION AGAINST THE RELEASED PARTIES.
